The original bearing the names of at least seven eligible applicants for membership including transfer members and reinstating members with the signature of the camp commander and camp adjutant and the endorsement of the division commander, will be sent to the adjutant-in-chief at International Headquarters. New member applications, reinstatements and transfer forms must accompany the charter application as provided by Article IV, Section 2 of the Constitution. The camp and the division commander should retain one copy each of the charter application form. Upon completion, the camp charter will be sent to the division commander for presentation.**
